*** The above withdrawals will be offered only at the Head Office Agency and Shkodra Agency, while withdrawals up to ALL 300,000 / EUR 2,000 are free of charge in the 24/7 ATM area, and withdrawals of ALL 500 / EUR 10 are free of charge at the service point.

**** The ATM withdrawal limit for the Master Card can be increased to ALL 1'000'000 / EUR 7'000, subject to prior approval.

***** Withdrawals without prior notification will be offered only at the Head Office Agency and Shkodra Agency. Foreign exchange offices that have agreements with the Treasury Unit are exempt from the withdrawal fee.

***** To obtain a stamp on the account statement, the client must visit the nearest service point.

**** For outgoing international transfers in CNY, the bank's official exchange rate will be applied when the transfer is ordered from current accounts in ALL/EUR/USD.

***** PROPAY refers to all transfers carried out within the ProCredit Bank network (Albania, Germany, Kosovo, North Macedonia, Bulgaria, Romania, Bosnia & Herzegovina, Serbia, Georgia, Moldova, and Ukraine). This category also includes ProPay outgoing international transfers (MT101).

General notes on Letter of Credit/Bank Guarantee fees & commissions

- 1. In case there is a tolerance regarding the Letter of Credit/Bank Guarantee amount, all fees & commissions will be applied on the amount of the Letter of Credit/Bank Guarantee, plus the foreseen tolerance.*
- 2. Issuance Fees & Commissions for a Letter of Credit/Bank Guarantee are calculated on a 360-day basis per year and are applied on a monthly basis. The fees & commissions for the first month are charged upon issuance of the Letter of Credit/Bank Guarantee and at the beginning of each month for the remaining period.*
- 3. Fees & Commissions paid cannot be refunded if the Letter of Credit/Bank Guarantee expires unused or is cancelled during this period.*
